- Set up time as follows: Saturday, September 13, 2014, 7:00 A.M. **NOTE: The Antique Fair Board reserves the right of final approval on space allocation. If your booth is not set up within the confines of your designated space, you may be required to disassemble and reassemble booth. Please be respectful to fellow vendors.**
- **Fee: \$50 for 10' x 20' space – does not include canopy or tables.**  
Applications postmarked after August 1, 2014, late entry fee is \$75.
- Application Deadline **September 6, 2014**  
**NOTE: Late applications will be accepted as space permits.**
- Exhibition and display rules for the Historic Bellefonte Antique Fair will be included with the acceptance letter. Fees are deposited upon receipt, but will be refunded in full if your application is not accepted (cancellations excluded).

### Vendor Requirements

- PA Sales Tax Licenses are required to be displayed when exhibiting.
- Applicant must be present entire duration of the Fair, rain or shine.

### Applications must contain the following items to be considered:

1. Application form completely filled out and signed.
2. Signed general release.
3. jpg. file on disc (or emailed) of your booth set up.
